TYPE OF PERMIT: PROHIBITED WEAPONS - SILENCER

Permit Holder: John Citizen

Signature of Permit Holder.

Authority:

This prohibited weapon permit authorises the permit holder to possess and use¹ prohibited weapons (silencer/s) for the genuine reason of vertebrate pest control as a professional contract shooter.

The authority conferred by this permit is subject to the Weapons Prohibition Act 1998 and the associated Regulation and all the General Legislative Requirements that apply to a prohibited weapon permit holder² (apply to this permit, in addition to the conditions outlined below).

Conditions:

- 1. A silencer may only be used in connection with authorised firearms that are registered to the permit holder for the genuine reason of vertebrate pest animal control as a professional contract shooter, and only on properties in NSW for which the permit holder has authority and holds a current contract.
- 2. Documentation of any purchase or sale of a silencer must be retained by the permit holder and produced to police upon request at any time.

Clause 126 Exemption for holder of prohibited weapons permit for silencer

(1) A person who is the holder of a permit under the Weapons Prohibition Act 1998 that authorises the person to possess and use a silencer is exempt from a provision of the Act that requires the person to be authorised by a permit to possess or use a prohibited firearm that is a firearm to which the silencer is fitted if the person is the holder of a licence under the Act that authorises the person to possess or use the firearm concerned.

(2) In this clause, silencer means an article or device capable of muffling, reducing or stopping the noise created by firing a firearm.

- 3. The silencer must be produced for inspection upon demand by a police officer at any time.
- 4. The authority of this permit remains valid whilst the permit holder continues to hold a valid Individual firearm licence for the genuine reason of Vertebrate Pest Animal Control as a Professional Contract Shooter.

Authorised Schedule 1 prohibited weapons:

Clause 4 (3) of Schedule 1 to the *Weapons Prohibition Act 1998* - Silencers or any other device designed for attachment to a firearm for the purpose of muffling, reducing or stopping the noise created by firing the firearm.

Safe Storage:

The permit holder must ensure that Level 2 safe keeping requirements, as prescribed by section 32C of the *Weapons Prohibition Act 1998*, are maintained for the prohibited weapons to which this permit relates.

For the purpose of this permit the prohibited weapons must be stored in an approved safe storage facility located at: 88 Plunkett Street, Nowra, NSW 2541

Authorised Silencer Calibre/s:

This permit authorises the possession of no more than eight (8) silencers of the following types:

Three (3) silencers to suit .22 calibre

One (1) silencer to suit a 243 calibre

One (1) silencer to suit a 17 calibre

One (1) silencer to suit a 17/22 calibre

One (1) silencer to suit a 7mm calibre

One (1) silencer to suit a 30 calibre
